A Year in Review

Well, what can I say? 2019 was a fine year and we were all looking forward to opening more services for families with a premature or sick baby in 2020, our fundraising and community support were on the increase and was allowing us to work on developing several new services, resources and projects all working toward our vision of 'better, healthier outcomes for newborns and their families challenged by prematurity or sickness.' August saw fantastic support from our *NSW CLUB Grants* partners. We also saw the amazing campaign of *\$1 Schnitty from Rashays* which was another highlight for the year. Our *Miracle Moon Walk* in September experienced an increase in participants and funds raised, with the night being a truly magical event. In November we celebrated *World Prematurity Day* and *Thank U NICU Day*, whilst raising awareness during our *November NICU Awareness Month* campaign.

Then we had deadly bushfires soar through many states which shocked the world, the ferocity and spread of the bushfires, the loss of life, both human and animals, property, habitats, livelihoods and at times totally life changing for those impacted. Christmas came and went through the hazy smoke of continued bushfires and not long afterwards we had floods bringing more loss and devastation. Early 2020 hit us with our first COVID-19 cases in Australia. We had been watching to overseas as we saw this deadly virus start to show its cruel and deadly hold on our human race.

The financial year for 2019/2020 started off quite well with our expansion plans, however by 2020 all our plans were put on hold and our current services were suspended in March 2020 with the threat of COVID-19 and state and federal restrictions. Our lives completely changed and we were now living in a world none of us ever expected. At Miracle Babies we put the health and safety of our families, staff, volunteers and community as first priority. Many of us started working from home, volunteers were stood down and our services put on hold.

Although the challenges, especially with funding coming to a grinding halt and many facing personal challenges with loss of jobs, we maintained our focus as to how we could continue to support our families and deliver our services to our most vulnerable families during the pandemic. We undertook a survey of parents which confirmed our parents were suffering increased anxiety. Our survey also found more than 79% of parents had an increase in parental anxiety because of COVID-19. Moreover, 57% were concerned about their overall parental mental health amid the current COVID-19 outbreak. We knew the more vulnerable people in our society were more susceptible to severe health impacts from COVID-19 which was of great concern for our tiny and vulnerable babies and families. Our survey found 90% of families consider their premature or sick newborn/s to be in the vulnerable group in relation to the current pandemic. Our families already suffer isolation, fear, uncertainty, anxiety – the pandemic increased all of this for families. So while in the business sense, it was hard to plan anything, we knew we had to be there for our families. They needed us now more than ever!

Our team worked hard and adapted quickly to deliver our in hospital family support services through an online platform, we opened these sessions to anyone needing support, either with their baby in hospital or at home. These *NurtureTime* Online sessions were held Monday through to Friday and are continuing as we navigate the unknown future for Australia and overcoming COVID-19. The demand for our resources increased as hospitals worked to continue providing families with this much needed support and connection. Our 24 hour support helpline, *NurtureLine* continues to be a valuable resource for families and calls during and after business hours rapidly increased.

During the pandemic, we have continued to work on vital projects with health professionals, in research, advocacy and consumer representation. In December I was thrilled to be announced as part of the Chair Committee of GLANCE, a global collaboration for the care of newborns and families globally.

Whilst the restrictions and health concerns for our families has meant that a lot of our usual activities and community events have not been able to proceed, we have been blessed with our supporters helping where they can. Thanks to assistance from the Australian Government and NSW Government and an amazing result to our *Quadruple Giving Day* in May and *Proud Grandparent's Project* in June we are still here, still supporting, still working toward our vision of 'better, healthier outcomes for newborns and their families challenged by prematurity or sickness.'

This year the Foundation experienced a loss for the financial year, our annual revenue for 19/20 being \$1,249,181 (2019: \$1,309,985, 2018: \$818,716). With strict budgets and very careful spending we have sustained a minimal financial loss for the financial year. We are looking forward to the rebuild and re-establishment of our *NurtureProgram* nationally, as state restrictions allow. We have been busy developing our new website for launch in late 2020 which will see a world first parent information hub for all life stages and the impacts and risks for our children as they grow and develop to adulthood. This awareness and education will assist parents and the children themselves as they grow to make improved life choices and continue to monitor their health and any ongoing concerns due to their early or sick arrival into the world.



Our corporate partners have been amazing and are all such an important part of our story. We thank you all, *Tommee Tippee, BabyLove, Water Wipes and Active Display.*

It has been an extremely tough year. Personally challenging and exhausting, although has also highlighted what an amazing team and community we have. We believe in and we see miracles every day, we just have to be ready to see those special moments. Thank you to our amazing Board, staff and volunteers, I truly hope I have been able to lead us through this pandemic with the best results yet to come. Thank you for those that have listened and supported me during some tough days and very hard decisions.

Thank you to our Founder Melinda Cruz for your never ending support. Melinda and I celebrated 10 years of staff service this year, add on 5 years of our committed volunteering and as Miracle Babies Foundation celebrated 15 years, so did we! What an amazing journey so far.

To all our miracle families and supporters, your health and safety remain our first priority. Our services and resources will continue to be delivered where we can in the safest way. Whatever part of the journey you are on, please know there is support, hope and guidance available and we appreciate the privilege of you allowing Miracle Babies to be there for you. You are not alone, we can support you through the toughest days and also the wonderful milestones and achievements. Together we are a community; Miracle Babies Foundation and you!

Report on the Audit of the Financial Report

We have audited the financial report of Miracle Babies Foundation Limited, which comprises the statement of financial position as at 30 June 2020, the statement of comprehensive income, statement of changes in equity and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies, and the responsible entities' declaration.

In our opinion the financial report of Miracle Babies Foundation Limited has been prepared in accordance with Division 60 of the *Australian Charities and Not-for-Profits Commission Act 2012* (ACNC Act), including:

- (a) giving a true and fair view of the registered entity's financial position as at 30 June 2020 and of its financial performance for the year then ended; and
- (b) complying with Australian Accounting Standards to the extent described in Note 1, and Division 60 of the Australian Charities and Not-for-profits Commission Regulation 2013.

Basis for Opinion

We conducted our audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Report* section of our report.

We are independent of the registered entity in accordance with the ethical requirements of the Accounting Professional and Ethical Standards Board's APES 110 *Code of Ethics for Professional Accountants* (the Code) that are relevant to our audit of the financial report in Australia. We have also fulfilled our other ethical responsibilities in accordance with the ACNC Code.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter - Basis of Accounting

(a) Audit Scope

The financial report has been prepared for the purpose of fulfilling Miracle Babies Foundation Limited's financial reporting responsibilities under the ACNC Act. As a result, the financial report may not be suitable for another purpose. Our opinion is not modified in respect of this matter.

(b) Subsequent Events

In accordance with ASA 720 'Subsequent Events'; we draw attention to Note 17 of the financial report regarding the current adverse financial ramifications evident from the COVID-19 Pandemic.

The pandemic has created the following uncertainties:

- (1) Maintaining positive financial results within a down turning economic environment;



- (2) Potential loss mitigation; and
- (3) Support strategies to ensure the appropriateness for using the going concern as a basis for accounting in the Financial Statements relying on future financial recovery.

At the date of this report the Directors have confirmed their best practice procedures to ensure the continued viability of the group by remedial actions to reduce trading expenses and ensuring the safety of its Directors and staff.

However, the ramifications of future financial losses and appropriateness in applying the 'going concern basis' for the Financial Statements cannot be confirmed or quantified at this stage. Therefore, doubt exists if the group can maintain its current levels of financial performance since such considerations are directly dependent upon the duration of the pandemic, the rate for both the global and Australian economic recovery 'as a whole' and the financial sustainability of the niche market in which the group operates.

Responsibility of the Responsible Entities for the Financial Report

The responsible entities of the registered entity are responsible for the preparation of the financial report that gives a true and fair view and have determined that the basis of preparation described in Note 1 to the financial report is appropriate to meet the requirements of the ACNC Act and the needs of its members. The responsible entities' responsibility also includes such internal control as the responsible entities determine is necessary to enable the preparation of a financial report that gives a true and fair view and is free from material misstatement, whether due to fraud or error.

In preparing the financial report, the responsible entities are responsible for assessing the registered entity's ability to continue as a going concern, disclosing, as applicable, matters relating to going concern and using the going concern basis of accounting unless the responsible entities either intend to liquidate the registered entity or to cease operations, or have no realistic alternative but to do so.

The responsible entities are responsible for overseeing the registered entity's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Report

Our objectives are to obtain reasonable assurance about whether the financial report as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion.

Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with the Australian Auditing Standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of the financial report.

As part of an audit in accordance with Australian Auditing Standards, we exercise professional judgement and maintain professional scepticism throughout the audit.

We also:

- Identify and assess the risks of material misstatement of the financial report, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omission, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the registered entity's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by responsible entities.
- Conclude on the appropriateness of responsible entities' use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the registered entity's ability to continue as a going concern. Our successful program is essential for all miracle families and comprises:

NurtureLine® – The first national 24 hour family helpline dedicated to assisting families of premature or sick newborns. Confidential support is provided by our trained parent support team who themselves have experienced the birth of premature or sick newborn.

NurtureTime® - Facilitated by qualified Miracle Babies Foundation NurtureProgram team, these in hospital parent support sessions operate within Australian NICUs. This vital, comforting and emotional support provides parents with the opportunity to share their journey with someone who has been there.

In the 2019/2020 financial year, **NurtureTime®** ran at **20 locations** within the Australian NICUs and SCNs. The service was temporarily suspended due to the global pandemic, COVID-19 in March 2020. To continue supporting families, **NurtureTime®** quickly adapted to **NurtureTime Online** via the Zoom platform, offering up to 10 sessions per week for families nationally at any stage of their journey.

NurtureGroup[®] - Out-of-hospital play and support groups offered at no cost to families and carers who have experienced the birth of a premature or sick newborn. Health professionals such as a speech therapist, physiotherapist, occupational therapist, social worker and family support nurse attend **NurtureGroups[®]** to provide information, assistance and advice on the children's development.

We commenced the 2019/2020 financial year with 20 **NurtureGroups[®]**. However, the service was temporarily suspended due to the global pandemic, COVID-19 in March 2020. To continue supporting families, **NurtureTime[®]** quickly adapted to **NurtureTime Online** via the Zoom platform, offering up to 10 sessions per week for families nationally at any stage of their journey.

It is vitally important that parents and their children have access to this ongoing support, our community of people who have gone through a similar experience can positively influence the emotional and physical outcome for families who have suffered such a traumatic experience.

NurtureGroup Online is supported by Newcastle Permanent Charitable Foundation and is a pilot trial of online services for families living in the rural and regional parts of Australia. Initially launched and available for families Central West, Hunter New England and the Northern Rivers region of NSW.

Miracle Babies Foundation NurtureGroup Online is a free support group for families who have recently experienced the birth of a

premature or sick newborn in the last 12 months, and who may live in a rural or regional area and can't attend a face-to-face NurtureGroup. We welcome all NICU and SCN families. Parents and carers can exchange ideas on parenting, tackle medical issues, share stories, build support networks, form friendships and ease the isolation that can often be felt by families of premature and sick newborns.

Health professionals in maternal and child health fields attend NurtureGroup Online intermittently to provide information, assistance and expert advice of the children's development. Professionals may include Physiotherapy, Occupational Therapy, Speech Pathology, Dietetics, Social Work, Psychology, Nursing and more.

NurtureProgram® Volunteers

Although Miracle Babies Foundation has many dedicated volunteers around the country who assist our work, only specialised, fully screened *NurtureProgram* team members, who themselves have experienced the birth of a premature or sick newborn are able to enter the *NurtureProgram*® and offer parent-to-parent support. In the 2019/20 FY, there were 11 new *NurtureProgram* volunteers onboarded for MBF services. This was a decrease on previous years due to the social distance restrictions that were in place due to the COVID-19 pandemic. Without the support of our volunteers, we would be unable to deliver this vitally important program.





NurtureProgram Resources

With the goal to positively change the experience for families during what can be a traumatic time, some of our resources include:

- **Emergency Care Packages**

Available to parents who have been admitted to hospital unexpectedly or transferred a distance from home. Provides personal care items most needed during the first 24-48 hours of hospitalisation.

- **NICU Survival Pack**

Equips parents with vital tools and resources as well as information about the availability of local NurtureGroups after leaving the safety of the hospitals care. Includes *Nurture*, an informative guide book that covers many aspects and concerns shared by parents to give readers a better understanding of neonatal care. Our unique and beautiful journals were developed to help families document and create a memento of their baby's early life.

- **Memory Boxes**

These beautifully designed keepsakes are to provide comfort for families of NICU babies who have passed.

- **Grad Bag**

A resource to help miracle families transition home from NICU or SCN. Includes information on Miracle Babies Foundation services after discharge i.e. *NurtureGroups*, the Going Home Booklet resource (helpful information to assist with the transition home, including information on sleeping, visitors, and when to call the doctor.

- **Milk Express Pack**

Milk Express Packs support and educate mothers on expressing breastmilk for their babies in the NICU and SCN and provide resources for safe storage and transportation of expressed breastmilk. As mothers are often discharged before their babies, they must often express breastmilk at home and transport it to their baby.

Miracle Babies Foundation is Australia's largest consumer group of families who have experienced the birth of a preterm and/or sick baby. Our role includes being a collective voice for the community and work alongside health professionals to advance health and improve the experience for miracle families.

Miracle Babies Foundation also advocates and supports continual advancement to support a families experience in the following:

Family Integrated Care (FICARE) This involves parents and family members to be the primary carers of their baby during their hospital stay in partnership with doctors and nurses. For this to be possible, hospitals need to have the everyday comforts and amenities available at home. These include kitchen areas, accommodation and rest/quiet rooms, childcare facilities, bathroom amenities, parking permits and transport assistance. These facilities must be close to the Neonatal Unit. Research has found that FiCare improves a babys weight gain, reduces infection, increases breastfeeding, reduces length of hospital stay and parental distress.

Unnecessary separation of mothers and their babies: Babies are routinely separated from their mother unnecessarily. A change in regulation that force premature babies to be separated from their mothers would result in improved breastfeeding rates, reduced length of hospital stay and parental distress, by keeping mothers and their newborns together.

Extended Parental Leave: A premature or sick baby can spend up to a year in hospital. When baby finally comes home parents may be required to return to work shortly after. There is currently no extended leave offered for families in Australia who have had a baby born early or critically ill. This limits the time spent together during a critical time of transition from hospital to home. Other countries have recognised additional financial needs of parents of premature babies when drafting their parental leave schemes.

Media

We had a very positive start to the financial year for our media coverage. Miracle Moon Walk ambassador and Rugby great Phil Waugh, appeared on the Ray Hadley Morning Show on 2GB/4BC and was interviewed by host John Stanley. Phil opened up about his own personal journey with a premature baby and why he was supporting the Miracle Babies Miracle Moon Walk event. The interview was featured in an online article and podcast.

New research in July 2019 from the University of Tasmania highlighted the ongoing impact premature birth can have on children into their school years. Miracle Babies Foundation contributed to an article written in The Australian and which featured an interview with one of our Miracle Mums. This research also allowed our founder Melinda Cruz to be featured on Channel Seven's Daily Edition alongside Neonatologist and Miracle Babies Board Member Dr Robert Guaran to discuss the research. In August 2019, founder Melinda Cruz was interviewed for Channel Nine's TODAY show to discuss premature birth. The segment also featured Miracle Babies ambassadors Sam Squiers and Deborah Knight.

Miracle Babies Foundation interviewed the creators of the hit children's cartoon Bluey to highlight their own personal journey with premature birth and how the topic is featured in the episode 'Early baby'.

Our message for World Prematurity Day on 17 November 2019 was to further draw attention to the gap in paid parental support for families of premature or sick newborns who require the support of a NICU or SCN. For World Prematurity Day Miracle Babies Foundation called on the Government to review the current parental leave legislation. Miracle Babies Foundation again worked with MediaCast to share this message and managed 144 items of coverage for World Prematurity Day, reaching an estimated 7 million people. TV highlights include ABC 7:30 with the Taufer family and Kylie Pussell and Weekend Sunrise segment with Miracle mum Natasha and expert, Dr Alicia Spittle. Radio coverage included 33 live interviews, including major syndicated shows such as 3AW, ABC Radio Melbourne, ABC Radio Brisbane, ABC QLD Statewide Drive and National Radio News.

In addition to our media campaign, we also promoted an online petition to the Australian Government where we asked the House to make priority a review of current legislation on parental leave, taking into consideration family needs for premature and sick babies and work towards improving parental leave for NICU/SCN parents. We asked for meaningful consultation about the issue to implement improved parental leave support for these families. The petition closed on the 24th December 2019 and garnered an impressive 5917 signatures. It was presented to the House and also referred to Minister for Government Services.

Despite the challenges the COVID-19 outbreak brought to 2020, our regular PR company MediaCast worked with Miracle Babies Foundation for our Miracle Month of May campaign. Our 2020 message focused on the research we conducted with our miracle community which revealed four in five parents of premature or sick children have experienced an increase in parental anxiety due to COVID-19. The campaign contained 58 items of coverage reaching an estimated 3.7 million people.

Broadcast highlights included: ABC NewsRadio, ABC Radio Perth, SBS language programs, and Triple M stations. And print highlights included: Herald Sun, Mama Disrupt, and Take 5 Magazine.

Premature birth is linked to significant behavioural and potential learning difficulties that persist beyond school age, if not longer, new research reveals.

Findings, from researchers at the University of Tasmania, suggest extra assistance may be needed for preterm children to ensure they do not carry those difficulties into school years and adulthood.

Researchers from the university's College of Health and Medicine conducted a series of tests on kindergarten children, 140 born prematurely and 80 at full term.

They found preterm children were "significantly behind" in tasks involving executive functions - those related to attention, concentration and self-control.

In one test, which challenged children to say "night" when presented with a picture of the sun and "day" when shown the moon, full-term children did twice as well as preterm children.

Researcher says that preterm children are at a disadvantage when it comes to school readiness.

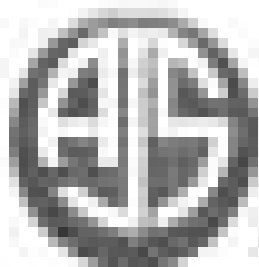
