This financial year has seen Miracle Babies Foundation receive a most blessed gift through a bequest that will have such a meaningful impact on our community for many years. This special and generous gift will allow us to be able to continue expanding the growth and access of our services to our most vulnerable families in the neonatal time spent in hospital with their premature or sick baby. Since 2023 we have been developing our new model of care for our in hospital service, *NurtureTime 15* where our program team members are in the hospital delivering cotside peer support to families for 15 hours per week, an increase from 3 hours per week. All our areas of work are experiencing a high demand, from our services, resources, consumer representation, advocacy, information and connection. Each year our team keep getting better at what we do and this in turn creates more supported and empowered families. Thank you all for your work, passion and dedication.

In April I was once again invited to attend the Parent Organisation Summit in Germany which also saw the change of EFCNI to GFCNI – marking a true global footprint for work to improve outcomes all across the globe.

Our *NurtureProgram* continues to expand and nurture more families. Through our 24 hour support helpline, cotside peer support in hospitals, support and play groups, resources at pivotal points of the hospital stay, together with evidence, education and empowerment through our globally awarded *Nurture E* information hub, The *EEE Impact*.

Our calendar of annual events once again saw great community engagement and connection for families.

I am so very proud of our special community, all who are committed to increasing our impact for premature and sick babies and their families. 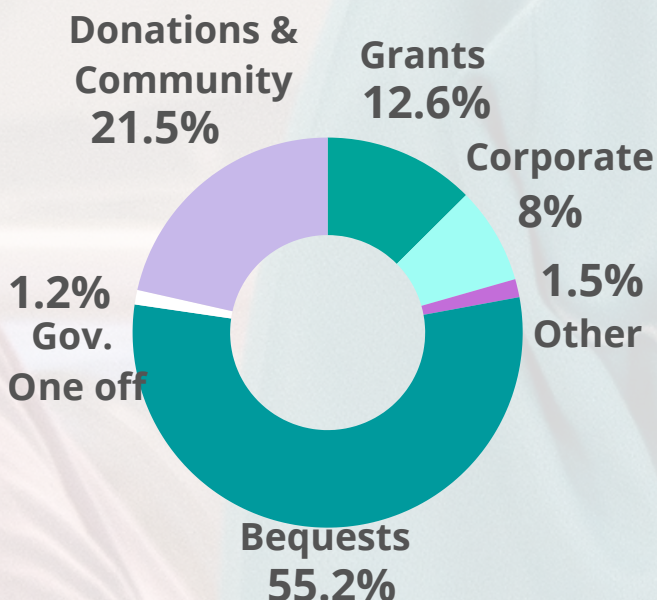

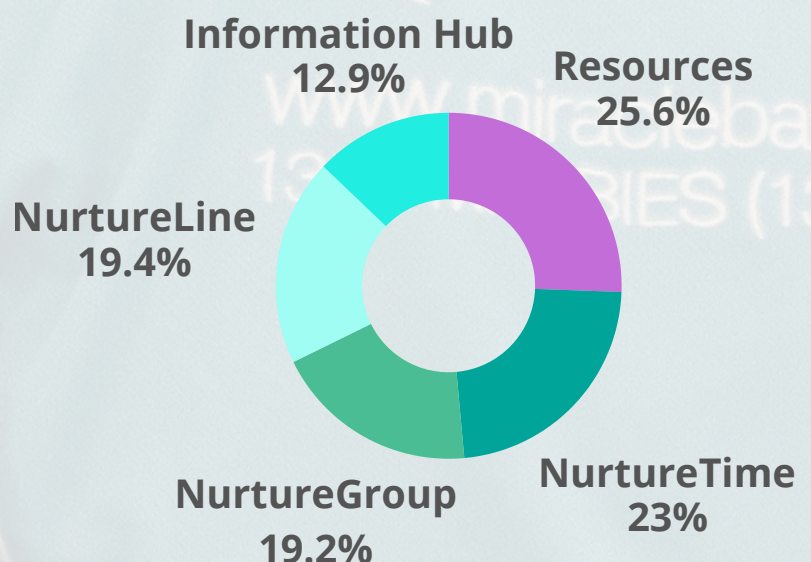

***NURTURE* PROGRAM**

OVERVIEW - SERVICES & RESOURCES

The globally recognised *NurtureProgram* consists of face-to-face peer support services, a support helpline and resources:

***NURTURE*LINE**

The first national 24 hour family support helpline dedicated to assisting families of premature or sick newborns. Confidential support is provided by our trained parent support team. Our Program Team are all parents themselves who have experienced the birth of a premature or sick newborn.

***NURTURE*TIME**

Facilitated by our qualified Miracle Babies Foundation *NurtureProgram* Support Team, these in hospital parent peer support sessions operate cotside within Australian neonatal units. This vital, comforting and emotional support provides parents with the opportunity to share their journey with someone who has been there.

***NURTURE*GROUP**

Support and play groups offered at no cost to families and carers who have experienced the birth of a premature or sick newborn after discharge.

***NURTURE* RESOURCES**

Our vital resources assist with the support, education and connection for parents throughout different needs of their neonatal journey.

Miracle Babies Foundation have a dedicated team around the country supporting families. Only specialised *NurtureProgram* team members, who themselves have experienced the birth of a premature or sick newborn are able to enter approved hospital neonatal units and offer parent-to-parent support. 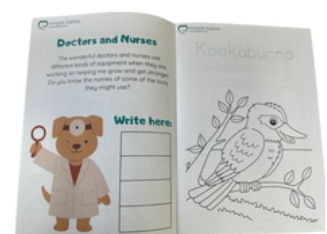
NURTURE RESOURCES

With the goal to positively change the experience for families during what can be a traumatic time, some of our resources include:

- **Emergency Care Packs:** Available to parents who have been admitted to hospital unexpectedly or transferred a distance from home. Provides personal care items most needed during the first 24-48 hours of hospitalisation.
- **NICU Survival Pack:** Equips parents with vital tools and resources as well as information about the availability of local *NurtureGroups*. Includes the *Nurture Guide*, an informative guide book that covers many aspects and concerns shared by parents to give readers a better understanding of neonatal care.
- **Memory Boxes:** These beautifully designed keepsakes are to provide comfort for families of NICU babies who have passed.
- **Grad Bag:** A resource to help miracle families transition home from the neonatal unit. Includes information on *NurtureGroups*, helpful information to assist with the transition home, including information on sleeping, visitors, when to call the doctor and more.
- **Milk Express Pack:** Milk Express Packs support and educate mothers on expressing breastmilk for their babies in the neonatal unit and provide resources for safe storage and transportation of expressed breastmilk.
- **Knitting and Sewing:** Dedicated groups throughout Australia assist in providing gowns, hats, booties, blankets, cuddle hearts and more.
- **Personalised Wall Plaques:** Engraved hearts displayed in the NICUs to acknowledge a baby's very special birth. These are currently available for the Liverpool Hospital NICU (NSW) Heart Plaque Wall.
- **Gifts:** A small acknowledgment provided to families in every Australian NICU on Mother's Day, Father's Day and Christmas.

- **Sibling Activity Pack:** Our Sibling Activity Pack is an activity booklet that has age-appropriate messages about how to connect with their new sibling and why they may not be home with them immediately. The pack is created especially for them to support their emotions and help them understand their important role as a sibling.

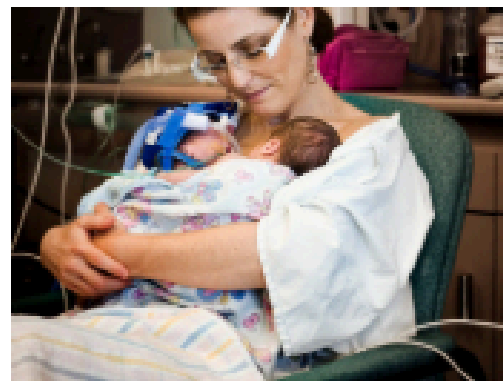
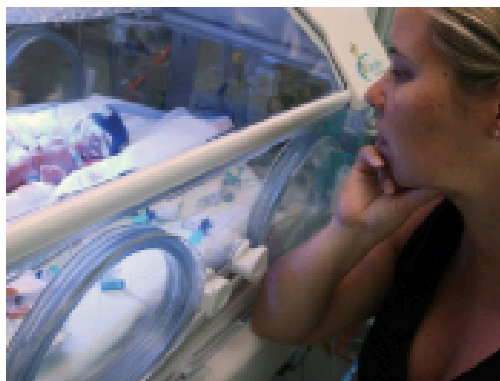

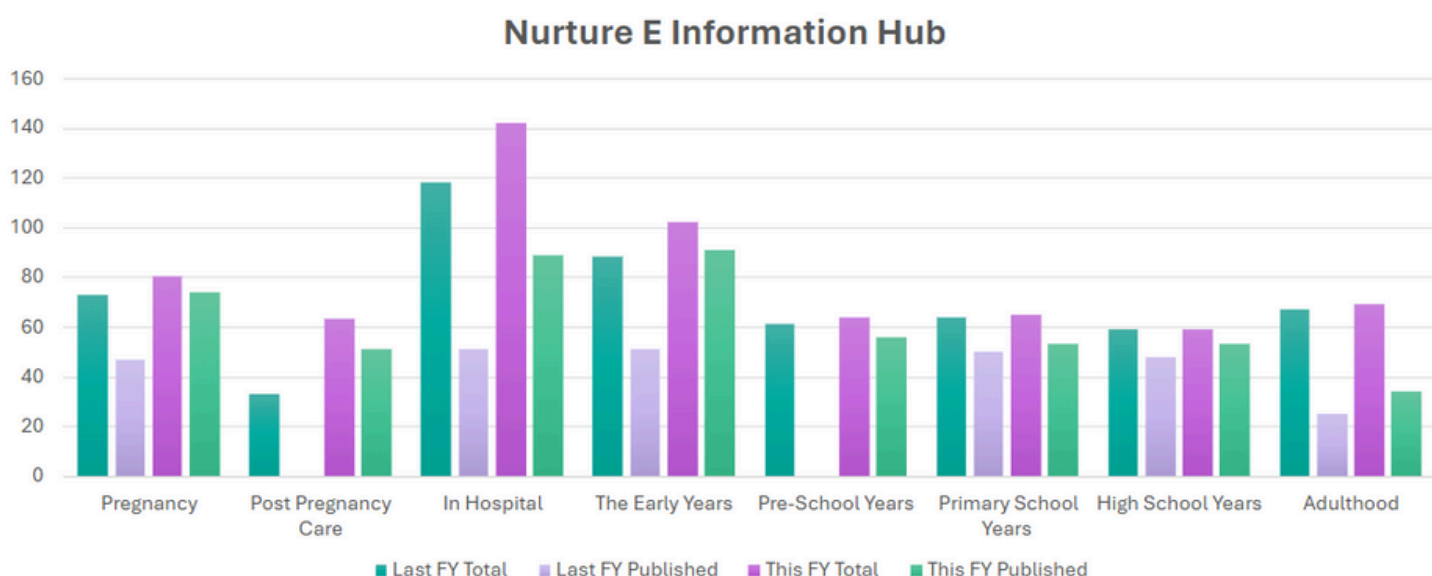

Nurture E - The EEE Impact has been created in collaboration with parents and health professionals to provide families with Evidence, Education and Empowerment.

Our aim through this initiative is to leave families feeling confident and empowered to better advocate and assist children during these exciting and vital development years. 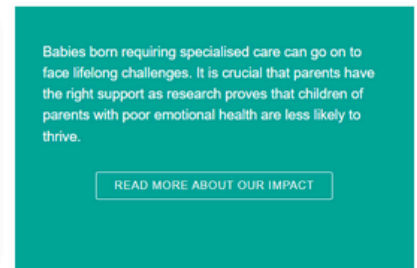
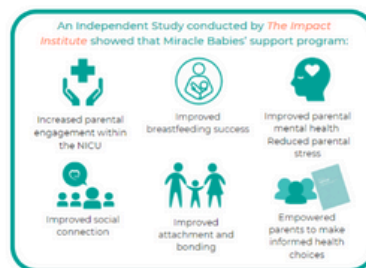
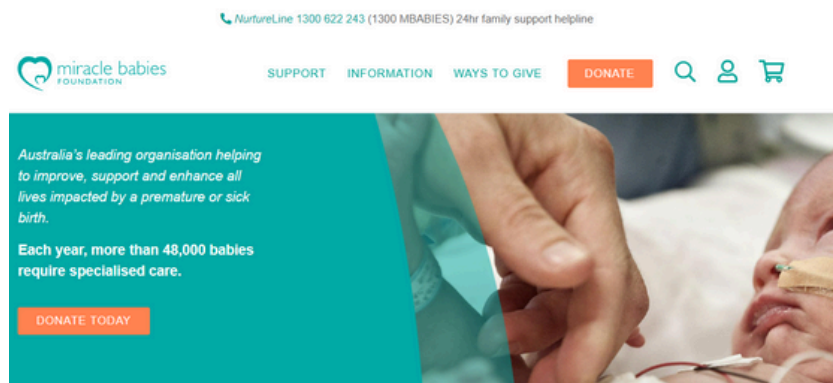

ADVOCACY, CONSUMER REPRESENTATION AND RESEARCH PROJECTS

Miracle Babies Foundation has established a national group of engaged and trained consumer representatives who contribute to research, advocacy and lived experience input across various projects and initiatives.

These representatives bring a wide range of lived experiences, including preterm birth, neonatal complications, long neonatal unit stays, stillbirth, bereavement, multiple births and regional transfers.

In the 2024/2025 period, Miracle Babies Foundation have supported a diverse portfolio of national and state-level neonatal and maternal health research projects. Involvement spans from advisory group participation, consumer engagement facilitation, grant application review and strategic project collaboration.

Once again Miracle Babies Foundation were part of the EFCNI Parent Organisation Summit, which formerly changed to the GFCNI – Global Foundation for the Care of Newborn Infants. We are proud of this partnership to represent Australia's neonatal family community with the global parent organisations and so much learning, collaboration and growing occurs. Our CEO, Kylie Pussell is on the GFCNI Parent and Patient Advisory Board, sharing her own lived experience and for purpose knowledge in improving care and outcomes for all lives impacted by a premature or sick birth.

Note 1 General Information and Statement of Compliance

Miracle Babies Foundation Ltd is a not-for-profit organisation that was initiated in 2005 by Melinda Cruz and the Liverpool Hospitals Newborn Intensive Care Unit.

The principle activities of Miracle Babies Foundation Ltd are described in the Director's report.

The financial report includes financial statements and notes of Miracle Babies Foundation Ltd.

The financial report of Miracle Babies Foundation Ltd for the year ended 30 June 2025 was approved and authorised for issue in accordance with a resolution of the directors on 5 November 2025.

Basis of Preparation

These general purpose financial statements have been prepared in accordance with the Corporations Act 2001, Australian Accounting Standards and other authoritative pronouncements issued by the Australian Accounting Standards Board (AASB), and comply with other requirements of the law, including the *Australian Charities and Not-for-profits Commission Regulation 2013*.

The entity does not have 'public accountability' as defined in AASB 153 *Application of Tiers of Australian Accounting Standards* and is therefore eligible to apply the 'Tier 2' reporting framework under Australian Accounting Standards.

The financial statements comply with the recognition and measurement requirements of Australian Accounting Standards, the presentation requirements in those Standards as modified by AASB 1060 *General Purpose Financial Statements - Simplified Disclosures for For-Profit and Not-for-Profit Tier 2 Entities* and the disclosure requirements in AASB 1060. Accordingly, the financial statements comply with Australian Accounting Standards – Simplified Disclosures.

Note 2 Changes in accounting policies and changes in estimates

The entity previously prepared general purpose financial statements (reduced disclosure requirements) as separate financial statements. In those financial statements (the 'previous reporting framework'):

- The recognition and measurement requirements of all Australian Accounting Standards were applied in preparing the separate financial statements of the entity on a stand-alone basis.

NOTES TO THE FINANCIAL STATEMENTS

Note 3 Summary of Significant Accounting Policies (Continued)

The financial statements have been prepared on an accruals basis and are based on historical costs unless otherwise stated in the notes. The accounting policies that have been adopted in the preparation of the statements are as follows:

a) Revenue

Revenue comprises of government and community grant, donations, fundraising activities, sales of goods and provision of services. Further information on revenue is shown on page 14.

Government and Community Grants

Grant revenue is recognised when the organisation obtains control of the grant and it is probable that the economic benefits gained from the grant will flow to the entity and the amount will flow to the entity and the amount of the grant can be measured reliably.

If conditions are attached to the grant which must be satisfied before it is eligible to receive the contribution, the recognition of the grant as revenue will be deferred until those conditions are satisfied.

When grant revenue is received whereby the organisation incurs an obligation to deliver economic value directly back to the contributor, this is considered a reciprocal transaction and the grant revenue is recognised in the statement of financial position as a liability until the service has been delivered to the contributor, otherwise the grant is recognised as income on receipt.

Miracle Babies Foundation Ltd receive non-reciprocal contributions of assets from the government and other parties for zero or nominal value. These assets are recognised at fair value on the date of acquisition except for goods for resale which are valued at nil dollars in the statement of financial position, with a corresponding amount of income in the profit or loss.

Sale of goods

Revenue from sale of goods comprises of revenue earned from the sale of goods donated and resold. Sales of goods revenue is recognised when the control of the goods has been passed to the buyer.

Donations/ Fundraising

Donations collected, including cash and goods for resale, are recognised as revenue when the gains control, economic benefits are probable and the amount of the donation can be measured reliably.

Provision of Services and Training Revenue

Revenue for services are recognised upon delivery of the service to the customers.

Sundry Revenue

Sundry Revenue is recognised upon control of a right to receive payment for services provided.

Other Income

Interest income is recognised upon receipt. Dividends income is recognised at the time the right to receive payment is established.

All revenue is stated net of the amount of goods and services tax (GST).

NOTES TO THE FINANCIAL STATEMENTS

Note 3 Summary of Significant Accounting Policies (Continued)

b) Operating Expenses

Operating expenses are recognised in profit or loss upon utilisation of services or at the services or at the date of their origin.

c) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand and deposits held at-call with banks.

d) Inventories

Inventories are measured at the lower of cost or net realisable value. Inventories acquired at no cost are not brought to account.

e) Property, Plant and Equipment

Each class of property, plant and equipment are carried at cost or fair value as indicated, less where applicable, accumulated depreciation.

Plant and Equipment

The carrying amount of plant and equipment is reviewed annually by the Board of Miracle Babies Foundation Ltd to ensure it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the assets employment and subsequent disposal. The expected net cash flows have not been discounted in determining recoverable amounts.

Plant and equipment that have been contributed at no cost, or for nominal cost, are valued and recognised at the fair value of the asset at the date it is acquired.

Depreciation

The depreciable amount of assets are depreciated on a diminishing value or prime cost basis over the asset's useful life to the entity commencing from the time the asset is held ready for use. The depreciation rates used for each class of depreciable asset are as follows:

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at least annually. An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

e) Property, Plant and Equipment (Continued)

Depreciation (Continued)

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are recognised immediately in profit or loss. When revalued assets are sold, amounts included in the revaluation surplus relating to that asset are transferred to retained earnings.

f) Leases

At inception of a contract, an assessment is made whether the arrangement is a lease. The arrangement is a lease if there is a right to control the use of a specific asset for a period of time in exchange for consideration. The relevant accounting standards provides guidelines and exemptions. At commencement date a lease is recognised as a right-of-use asset and a lease liability on the statement of financial position. Lease payments are split between amortisation and interest on the statement of profit & loss over the life of the lease.

g) Employee Benefits

Provision is made for the organisation's liability for employee benefits arising from services rendered by all employees from the date of employment to the end of the reporting period. Employee benefits that are expected to be settled within one year have been measured at the amounts expected to be paid when the liability is settled. The measurement of employee benefits payable later than one year has taken into account the present value of future cash flows including potential employee wage increases and the probability that the employee may not satisfy the vesting requirements.

Contributions are made by the organisation to applicable superannuation funds and are charged as expenses when incurred. Liabilities for superannuation are recognised in payables and measured at the amounts expected to be paid when the liability is settled.

Employee benefit on-costs are recognised and included in employee benefit liabilities and costs when the employee benefits to which they relate are recognised as liabilities.

Note 3 Summary of Significant Accounting Policies (Continued)

h) Provisions, Contingent Liabilities and Contingent Assets

Provisions are measured at the estimated expenditure required to settle the present obligation, based on the most reliable evidence available at the reporting date, including the risks and uncertainties associated with the present obligation. Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. Provisions are discounted to their present values, where the time value of money is material. Any reimbursement that Miracle Babies Foundation Ltd can be virtually certain to collect from a third party with respect to the obligation is recognised as a separate asset. However, this asset may not exceed the amount of the related provision. No liability is recognised if an outflow of economic resources as a result of present obligation is not probable. Such situations are disclosed as contingent liabilities, unless the outflow of resources is remote in which case no liability is recognised.

The liability for deferred income is the unutilised amounts of grants received on the condition that specified services are delivered or conditions are fulfilled. The services are usually provided or the conditions usually fulfilled within 12 months of receipt of the grant. Where the amount received is in respect of services to be provided over a period that exceeds 12 months after the reporting date or the conditions will only be satisfied more than 12 months after the reporting date, the liability is discounted and presented as non-current.

i) Deferred Income

The liability for deferred income is the unutilised amounts of grants received on the condition that specified services are delivered or conditions are fulfilled. The services are usually provided or the conditions usually fulfilled within 12 months of receipt of the grant. Where the amount received is in respect of services to be provided over a period that exceeds 12 months after the reporting date or the conditions will only be satisfied more than 12 months after the reporting date, the liability is discounted and presented as non-current.

j) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivable and payables are stated inclusive of the amount of GST receivable or payable. Accrued expenses are brought to account net of GST as the condition precedent to claiming the input tax credit has not been met. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to, the ATO are presented as operating cash flows included in receipts from customers or payments to suppliers.

k) Income Tax

No provision for income tax has been made in the financial report as the organisation is exempt from income tax under section 50-5 and section 11-5 of the Income Tax Assessment Act 1997 as it is and charitable institution. Miracle Babies Foundation Ltd has been endorsed by the Australian Taxation Office (ATO) as an income tax exempt charitable entity under Subdivision 50-B of the Income Tax Assessment Act 1997.

l) Economic Dependence

Miracle Babies Foundation Ltd are dependent upon the ongoing receipt of Federal and State Government grants and community and corporate donations to ensure the ongoing continuance of its program. At the date of this report, management has no reason to believe that its financial support will not continue.

m) Significant Management Judgement In Applying Accounting Policies

When preparing the financial statements, management undertakes a number of judgements, estimates and assumptions about the recognition and measurement of assets, liabilities, income and expenses.

Estimation Uncertainty

Information about estimates and assumptions that have the most significant effect on recognition and measurement of assets, liabilities, income and expenses are provided below. Actual results may be substantially different.

Impairment

In assessing impairment, management estimates the recoverable amount of each asset or cash-generating unit, based on expected future cash flows and uses an interest rate to discount them. Estimation uncertainty relates to assumptions about future operating results and the determination of a suitable discount rate.

Useful Lives of Depreciable Assets

Management reviews its estimate of the useful lives of depreciable assets at each reporting date, based on the expected utility of the assets. Uncertainties in these estimates relate to technical obsolescence that may change the utility of certain software and IT equipment.

Inventories

Management estimates the net realisable values of inventories, taking into account the most reliable evidence available at each reporting date. The future realisation of these inventories may be affected by future technology or other market-driven changes that may reduce future selling prices.

Long Service Leave

The liability for long service leave is recognised and measured at the present value of the estimated cash flows to be made in respect of all employees at the reporting date. In determining the present value of the liability, estimates of attrition rates and pay increases through promotion and inflation have been taken into account.

VOLUNTEERS

Miracle Babies Foundation has many dedicated volunteers around the country who assist our work through ongoing resource packing (helping to fulfil more than 9,000 resource packs per year and a further 4,000 special days gifts), knitting and sewing, supporting with events such as High Tea, Miracle Moon Walk and fully screened and trained *NurtureProgram* volunteer team members.

We recently formed the Neonatal Critical Care Alliance to increase our advocacy for additional paid parental leave for parents with a baby in neonatal care beyond 2 weeks. The Alliance is led by Miracle Babies Foundation, The University of Melbourne together with HeartKids, Tresillian, Birth Trauma Australia and Cerebral Palsy Alliance. Thank you to the families, health care professionals and supporting organisations so far, we will continue to advocate for this much needed change for vulnerable families and for all babies to go home with the same amount of paid parental leave entitlements as their healthy full term peers.

LIGHT IT PURPLE

Falling on 17 November, World Prematurity Day is the largest worldwide initiative to raise awareness for newborns born too early.

The global '**Light It Purple**' initiative is a collaboration between parent organisations across the world, calling on landmarks and businesses to 'light it purple' raising awareness of prematurity and the associated challenges. 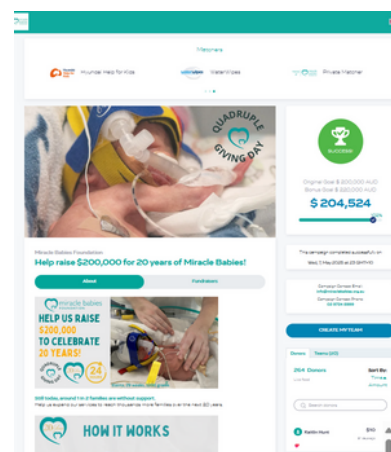
With all the support from the community and incredible sponsors, they reached their fundraising goal, bringing the total amount to an amazing \$50,482!
